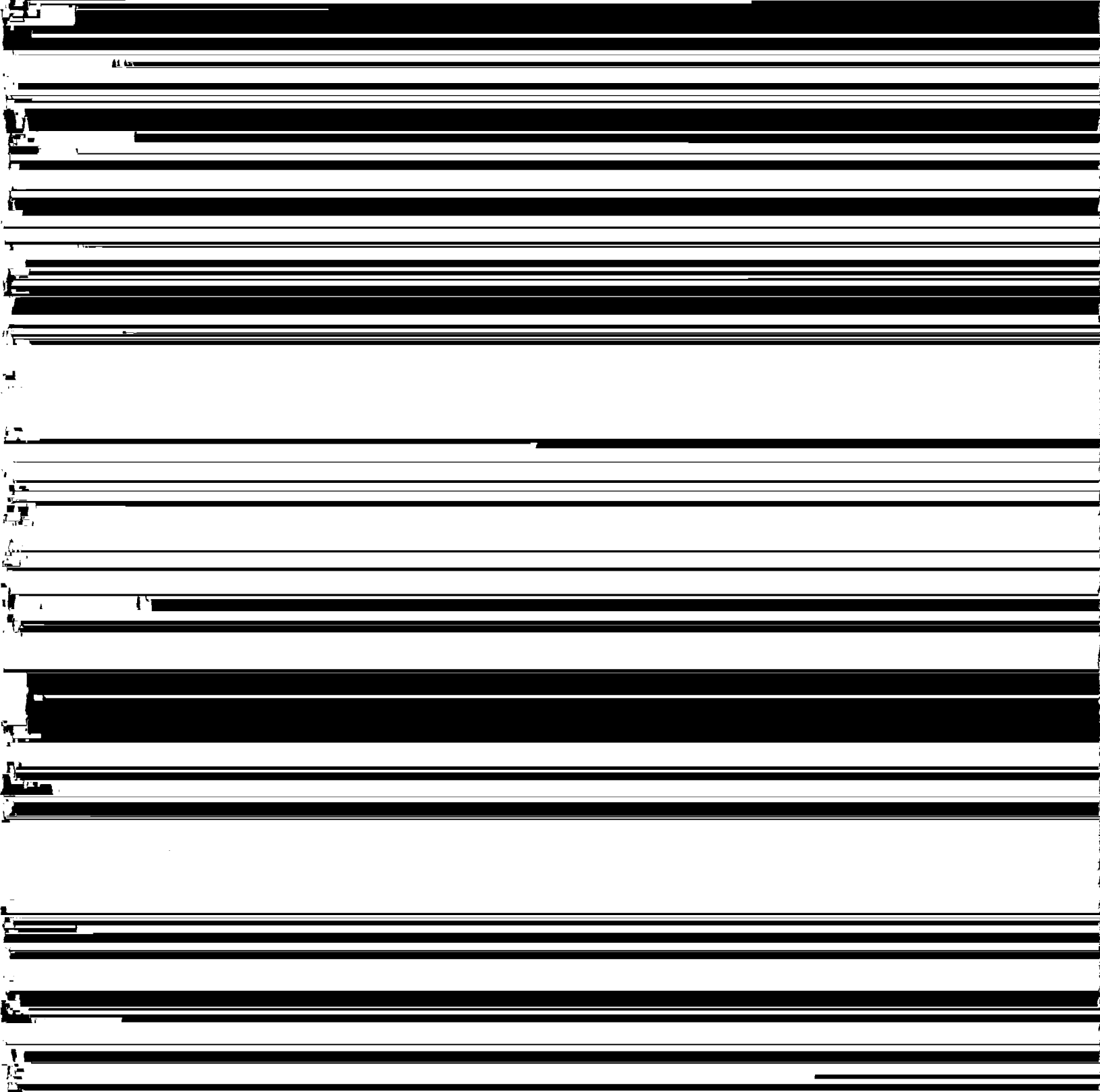
this contract will be subject to aggregated compliance reviews, reported on a bi-annual basis.
