THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

That the Board approve the establishment, opening and attendance boundary of a new elementary school, effective July 1, 2010, to be known on a temporary basis as West Lawn Elementary School ("West Lawn") located at 4707 West Marquette

Road and adjust the attendance area boundaries for Edward N. Hurley Elementary School ("Hurley") located at 3849 West 69th Place, Richard Henry Lee Elementary School ("Lee") located at 6410 South Tripp Avenue, and Louis Pasteur ("Pasteur")

located at 5825 South Kostner Avenue.


