THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

AFFIRMATIVE ACTION: Pursuant to Section 5.2 of the 2007 Remedial Program for Minority and Women-Owned Business Enterprise Participation in Goods and Services Contracts, a determination shall


be made as to when transactions should be excluded from contract specific M/WBE goals. It has been determined that the participation goal provisions of the Program do not apply to transactions where the pool of providers includes not-for-profit organizations
